**Law Enforcement Report:** Specialist McCarty provided the law enforcement report for the month of May. Indian Springs Arrests: 2 DWI, no public intoxication, 1 narcotics, 1 criminal mischief, no burglary of a motor vehicle, 1 burglary of a building and no burglary of a home. There were 15 vehicle crashes this month across Indian Springs. Indian Springs had a total of 523 calls for service including 136 area patrols, 171 vacation watches, 23 welfare checks, 16 suspicious persons, 4 suspicious vehicles, and 7 arrests.

Aging in Place – Pat Goodpastor spoke and thanked the board for the contribution. The organization's mission is to provide a caring environment and help residents stay in their houses longer – with transportation, housechores, and social visits via phone. There is a membership fee for \$100 per year per household.

**Treasurer's Report:** Tripp provided notes for the meeting and to be inserted:

Received the township money and green up checks, but haven't cleared yet. There is a \$500 credit for the township check, which is why you see the disparity in Chase balances. But if you add up unreconciled expenses and income - the \$500 credit you will see that it equals \$10042.40. Payed the storage unit fees through the end of year, which totaled \$457.60. Cost increase of 21% for the next 6 months. Coming due is insurance and spring fling expenses.
