Call to Order: Michael Saucier called the joint meeting to order at 7:00 p.m.

Neighbors', Elected Officials and Candidates Comments:

Jeff 'The Woodlands Weather Dude' Royed brought to the attention on the increase in power outages in the Alden Bridge Village.

Law Enforcement Report: Specialist Aguilar provided the law enforcement report for the month of December. Indian Springs Arrests: 3 DWI, no public intoxication, 1 narcotics, 1 criminal mischief, 1 burglary of a motor vehicle, no burglary of a building and no burglary of a home. There were 14 vehicle crashes this month across Indian Springs. Indian Springs had a total of 631 calls for service including 214 area patrols, 142 vacation watches, 54 traffic contacts, 19 welfare checks, 7 suspicious persons, 6 suspicious vehicles, and 7 arrests.

- The Woodlands won National Night Out National Award; 2024 theme is 'Set It, Don't Forget It, Get Alarmed' to remind people to set alarms, locks homes and vehicles and keep fire alarms up to date

Old / Recurring Business:

Parks & Recreation Advisory Council – Tina provided an update:

- Parks and Rec is still researching utilization of the new Central Park
- Falconwing park is in progress and need to reach out for the creation of plaque and bench
- Reforestation projects have started and Tina will follow up on schedule for Trace Creek
- Large culdesacs will now be maintained quarterly
- App is not currently working so any issues should be called in
- 50th year celebration is October 19

RDRC Update – Mike Vesely provided an update on recent requests. These include approvals for house colors of painted gray and white. Additionally, a resident painted their fence blue within the Woodlands Reserve;

however, it was unanimously rejected by the RDRC. The RDRC committee referred the issue to the DSC for their ruling as they are the entity that establishes these standards.
