**Call to Order:** Michael Saucier opened the meeting at 7:00 p.m.

**Law Enforcement Report:** Specialist Tavarez provided the law enforcement report for the month of February. Indian Springs had 3 DWI, 1 public intoxication, 2 narcotics arrest, 2 criminal mischief, 7 burglary of a motor vehicle, no burglary of a building and 1 home burglary. There were 14 vehicle crashes this month across Indians Springs. Responded to 797 calls for service, 18 alarms, 321 area patrols, 17 suspicious persons, 176 traffic stops, 13 vacation watches in Indian Springs.

MCSO reminds residents of the new initiative around autism and the 9PM routine.

#### Neighbors', Elected Officials and Candidates Comments: None

Dr Ann Snyder gave a report of the Township

- 3 COVID testing sites are currently operating from 8-5 and will be expanding 8-6 after daylight savings time
- Treeventures will be open starting spring break; Riva Rd boat house still requires reservations
- Forestgate Park slide and Falconwing Park restrooms, pool and playground are in the 2021 budget

**Bob Daily from Woodlands Water** spoke regarding groundwater. Aquifers have declined up to 120 feet across the county. Population is expected to double by 2040 creating a further crisis based on current depletion. With depletion of aquifers, the subsidence of several feet in the Woodlands (up to 10 feet in Harris County) within the last 30 years. However, groundwater usage has decreased due to both water usage per person in the Woodlands cut in half since 2011 and the conversion in 2016 where The Woodlands began using 60/40 with surface water.

**Secretary's Report:** February meeting minutes were approved.

**Treasurer's Report:** Ken provided the monthly report. Proposed 2021 budget was approved following amendment to remove funding for elementary school projects. No changes to the financial report.

**The Woodlands Township:** John Osborne distributed The Woodlands Township list of events and has submitted paperwork for Taste of the Village. This year's village challenge is again through Safe to Save and will run April 1-30. Fire Station open house is scheduled for June 19 at Fire Station #8.

**Old / Recurring Business:**

**Parks & Recreation Advisory Council** – There was no parks and rec meeting this month.

**RDRC Update** – ISVA RDRC boards will be fully represented after the election.

**Law Enforcement Board** – No updates

**Earth Day Green Up** – check in is March 20 from 8-10 at Falconwing Park.

**Woodlands Magazine** – May article to cover green-up

**ISVA Website and Facebook Page** – Michael Saucier is now the owner of the Facebook page and Tripp will be a backup editor.

**Scholarship Committee** – Application is still available online and Ree will be picking up the week after spring break. Michael will distribute invite for the selection committee.
