Indian Springs had 4 DWI, no public intoxication, no narcotics arrest, 1 criminal mischief, 3 burglary of a motor vehicle, 1 burglary of a building and no home burglary. There were 23 vehicle crashes this month across Indians Springs.

MCSO provided a video about the Real Time Crime Center (RTCC) and are now working with business for access to cameras around the time of crimes. Businesses can contact MCSO to enroll in the program.
